HB 1, making appropriations for the expenses of certain departments of the state for fiscal years ending June 30, 2020 and June 30, 2021.

Finance: OTP/A 13-9

ANTI-LIBERTY: This bill makes appropriations in excess of current tax sources and increases spending by \$565 million over the prior biennium.

- This budget dramatically increases New Hampshire spending going beyond the excessive levels requested by the governor by planning to spend an additional \$300 million beyond his proposed budget.
- The level of spending proposed will require new taxes including a capital gains tax that will forever alter the fiscal landscape of New Hampshire.

HB 2, relative to state fees, funds, revenues, and expenditures.

Finance: OTP/A 13-9

ANTI-LIBERTY: This bill includes a tax on earned income, a new tax on capital gains, and sets the state up for future expansion of taxes on income.

- This bill creates a new tax on capital gains in New Hampshire. Capital gains taxes make capital investments more expensive, and therefore less investment occurs.
- This bill contains a new mandated family medical leave program that is funded via a 0.5% tax on earned income. Employees and employers should be free to negotiate benefit programs such as paid family and medical leave insurance without the state forcing all to participate. - The commissioner of the Department of Employment Security will be empowered to raise the earned income tax rate or lower the benefits, up to 10%, without legislative approval.
