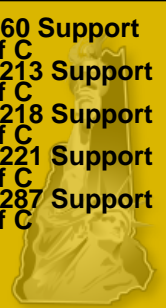

## House Bills

**HB 60, relative to the termination of tenancy at the expiration of the tenancy or lease term.**

## HB 60

**Committee of Conference: Adopt C of C**

**PRO-LIBERTY: This bill allows a landlord to evict a tenant at the end of a lease without cause.**

**The landlord is required to give 60 days notice.**

- A party to a contract should not need cause to end it at the conclusion of the contract term.
- A property owner should be able to do whatever they like with their property without government intervention.

## Senate Bills

**SB 213, (New Title) relative to electioneering by public employees.**

## SB 213

**Committee of Conference: Adopt C of C**

**PRO-LIBERTY: This bill forbids electioneering by public employees. It also requires proof of identity, citizenship, age, and domicile when applying for an absentee ballot.**

- This bill protects voters from improper influence by public employees.
- Absentee voting can lead to manipulation of election outcomes through the use of ballot harvesting. Great care should be taken to ensure that absentee voting is used properly.

**SB 218, (New Title) relative to absentee ballots.**

## SB 218

**Committee of Conference: Adopt C of C**

**PRO-LIBERTY: This bill requires an applicant for an absentee ballot to provide documentation proving citizenship, age, domicile, and identity.**

- In order to ensure the integrity of our state's elections, the use of absentee ballots should be restricted to only those who absolutely must vote by absentee.
- Lax rules for absentee voting in other states have led to the rise of ballot harvesting. Ballot harvesting takes the power away from voters and gives it to special interests who will work to obtain the most absentee ballots, rather than convince voters of the value of their ideas:

**SB 221, (New Title) relative to the verification of voter rolls annually.**

## SB 221

**Committee of Conference: Adopt C of C**

**PRO-LIBERTY: This bill requires annual verification of voter rolls. It purges voters who have not participated in an election in more than 5 years.**

- Ensuring that an accurate list of eligible voters is maintained is an important safeguard for the integrity of elections.
- Verifying the voter rolls allows for greater government transparency for those who have concerns about how the government is handling local elections.
