HB 1130, relative to judicial performance evaluations.

Finance: OTP/A 13-12

PRO-LIBERTY: This bill expands judicial performance reviews to apply broadly to all judges and judge-like public servants.

- This bill adds more transparency and accountability for the judiciary.

HB 1421, modifying title exemptions for motor vehicles manufactured before the year 2000.

Finance: OTP 25-0

PRO-LIBERTY: This bill, with the proposed committee amendment, exempts vehicles more than 20 years old from the requirement to obtain a certificate of title.

- Vehicles manufactured before 2000 currently need a title in order to sell, register, or reassign as property. The fee to retitling a vehicle at point of sale is both an expense to the owner or buyer and a time-consuming process to get retitled and get the title sent.
- This bill makes it easier to sell or scrap old vehicles, removes obstacles for transferring abandoned vehicles, and is favorable for collectors, younger, or less financially established people to purchase or trade vehicles within the state without a bureaucratic layer costing both money and time in a transaction between two entities that does not involve the government.

HB 1477, relative to the permitting and regulation of anchored seasonal floating platforms on public waters.

Finance: ITL 14-11

ANTI-LIBERTY: This bill creates a registration, permit process, and fee for floating platforms and creates a criminal penalty for failure to buy a permit.

- There are already legal guidelines for waterfront owners to anchor floating platforms.
- This adds a fee and a law enforcement penalty to force compliance under penalty of law.
- This is an encroachment on fair usage that has been understood for waterfront property owners and camps throughout the state.

HB 1477

HB 1809, authorizing the medical use of psilocybin through a program established in the department of health and human services.

Finance: ITL 13-11

PRO-LIBERTY: This bill authorizes the medical use of psilocybin in the state.

- Adults who are competent and fully informed of the benefits and risks of a particular medical treatment should be allowed to choose whether or not to have that treatment. The government should not arbitrarily get in the way.

HB 1542, (New Title) allowing alternative compliance payments to the renewable energy fund to be refunded to ratepayers on a per kilowatt hour basis.

Ways and Means: OTP/A 10-8

PRO-LIBERTY: This bill eliminates the renewable energy fund compliance payments.

- The net effect of this reduction will be a refund in costs for ratepayers.
- The money that is collected from these fees supports the renewable energy fund, which provides grants to support solar energy projects. If these projects are of a value to communities, they will fund them without state grants ostensibly provided by electricity providers.

HB 1542

ANTI-LIBERTY: This bill is a tax on properties adjacent to a body of water created by a state-owned dam.

- Dams are public resources created for a public benefit, which is to provide a stable and reliable water supply.
- Funds to maintain public infrastructure should be allocated in the biennial budget, not through a targeted tax on certain property owners.
