HB 1376, relative to a parent's ability to raise their child in a manner consistent with the child's biological sex.

HB 1376

Children and Family Law: OTP/A 2-1

PRO-LIBERTY: This bill makes clear that raising your child as their biological sex is not a crime.

- This bill strengthens parental rights. Parents have a primary right to direct the upbringing, education, and medical decisions of their own children.
- This bill stops the state from imposing contested gender ideology through coercive power, preserving individual liberty and parental authority.
- This bill restores clear, objective boundaries around what constitutes genuine child abuse, preventing vague and politically motivated expansions of state power that could be weaponized against dissenting parents

YEA OTP/A

HB 1792, prohibiting school districts and personnel from the instruction of critical race theory and LGBTQ+ ideologies in schools as well as establishing a private right of action for violations.

HB 1792

Education: OTP/A 3-2

PRO-LIBERTY: This bill institutes several reforms to prevent teaching discrimination. These include not endorsing certain points of view, or basing grades upon their agreement with a point of view expressed by a student.

- This bill promotes the ideas this country was founded upon, that all men are created equal, and that no one group is born inferior to another.
- This bill promotes non-discrimination of all groups of people while requiring educators to remain neutral and encourage free thought.

HB 1300, (New Title) establishing a biennial school district local tax cap question and related limitations on central office administrative expenses in school districts.

HB 1300

Election Law and Municipal Affairs: OTP/A 3-2

PRO-LIBERTY: This bill allows the voters to cap the local taxes related to school district spending. As amended, it will only propose the tax cap in the upcoming November election.

- The March town elections low turnout, generally around 20 percent of registered voters. In the November elections, that number is closer to 80 percent.
- This bill strengthens democracy by giving more voters a voice in their local school board's budget. Asking this question of the voters when there is higher turnout allows more voters to weigh in on local property tax issues.
- This is an NHLA priority bill and will be highly weighted in the Liberty Rating.

YEA OTP/A

HB 360, (New Title) prohibiting public schools from performing surgical procedures or prescribing pharmaceutical drugs.

HB 360

Health and Human Services: OTP 4-1

PRO-LIBERTY: This bill prevents any school physician or nurse, or other health care provider employed or contracted by a school district, to perform surgical procedures or prescribe pharmaceutical drugs on school grounds.

- Parents have the right to determine health care for their child. This bill will restore parental rights by limiting what medical procedures can be administered by the school district.
- It would be more appropriate to refer the child to their primary care physician who has the child's medical history and parent present when determining medical treatments.

YEA OTP

HB 1219, relative to immunization requirements in foster family homes.

Health and Human Services: OTP 3-2

PRO-LIBERTY: This bill removes the requirement to vaccinate children or parents in a foster home.

- Getting vaccinated is a medical choice, not a mandate.
- This bill adds consistency to vaccine requirements for adults and children residing in foster homes.
- Freedom of religion is engrained in the NH Constitution. This bill protects one's religious beliefs by extending medical exemptions to adults who reside if foster homes.

HB 1219

HB 1584, directing the department of health and human services to provide notice of medical and religious exemptions from immunization requirements and relative to the form of such exemption.

Health and Human Services: OTP/A 4-0

PRO-LIBERTY: This bill requires the Department of Health and Human Services to provide notice of the option to request a medical or religious exemption from immunization requirements.

- This bill will help to inform parents of their medical and religious rights under RSA 141-C and will reduce coercion by the Department of Health and Human Services.

HB 1772, (New Title) relative to prescribing ibogaine for investigational use only.

Health and Human Services: OTP/A 4-0

PRO-LIBERTY: This bill allows physicians licensed to prescribe drugs in New Hampshire to prescribe ibogaine for research purposes.

- Adults who are informed of the benefits and risks should be able to consent to try experimental treatments if they choose.

HB 1365, relative to applications for licenses to carry a loaded pistol or revolver.

Judiciary: OTP/A 3-2

PRO-LIBERTY: This bill prohibits pistol/revolver license application forms from requesting employment, personal references, or record disclosure information beyond what was required on the December 2009 version of form DSSP 85.

- This bill moves the needle in the direction of allowing more people to exercise their second amendment rights without administrative burdens getting in the way.
- This bill is a step in the right direction of protecting a person's personally identifiable information in public records which can easily be accessed by bad actors.

HB 1365

HB 1793, prohibiting public colleges and universities from regulating the possession or carrying of firearms and non-lethal weapons on campus.

Judiciary: OTP/A 3-2

ANTI-LIBERTY: This bill as amended establishes a committee to study the issue of campus carry.

- NHLA is in support of Campus Carry. We oppose the amendment and request an OTP motion.
- There is no need to study this issue. Adults should have the right to lawfully exercise their 2nd Amendment rights on college campuses.

HB 1793

HB 609, Relative to the general court's authority over the sale, purchase, ownership, use, possession, transportation, licensing, permitting, taxation, and other matter pertaining to firearms, stun guns, Tasers, pepper spray devices, knives and other self-defense tools.

Judiciary: OTP/A 3-2

ANTI-LIBERTY: This bill, as amended, allows local governments to pass zoning ordinances regulating firearms and other self-defense tools. As amended, it also makes the "State" the regulatory authority instead of the General Court.

- The House version of the bill specifically granted authority to regulate firearms to the General Court. The current definition of "State" allowed enough ambiguity to allow state agencies potential rulemaking authority pertaining to firearms.
- The Senate amendment reverses that change and returns authority to the State instead of the General Court. This is opposite of the intended purpose of this bill.
- Additionally, by allowing local zoning to regulate firearms, this amendment erodes the General Court's jurisdiction further.
- NHLA supports OTP on the original version of HB609 without any amendments.
